

U.S. Christians projected to fall below 50% of population if recent trends continue

Scenarios

○ No switching

This scenario imagines no person in America has changed or will change their religion after 2020.

O Steady switching

Movement into and out of Christianity remains stable at recently observed rates. That is, in each new generation, 31% of Christians become religiously unaffiliated before they turn 30, and 21% of unaffiliated people become Christian.

O Rising disaffiliation with limits

In each new generation, a growing share of Christians switch out before they turn 30, while a shrinking share of 'nones' switch in. But the switching rate is capped to prevent the share of Christians who leave the faith from rising above 50%.

O Rising disaffiliation without limits


In each new generation, a growing share of Christians switch out before they turn 30, while a shrinking share of 'nones' switch in. No cap is imposed on switching rates.

U.S. 'nones' will approach majority by 2070 if recent switching trends continue


% of Americans who are religiously unaffiliated



St. Thomas is offering a Grief Group led by facilitators where participants will have the opportunity to find support and practical resources. It is open to those who have experienced the death of a partner, child, family member, or close friend; participants do not need to be members of St. Thomas.

- Through our lay volunteers, we offered care through Touchpoints, Stephen Ministry, Lay Eucharistic Visitors, and a Grief Group.
- Clergy also visited people in hospitals, at home, and over the phone.

We grew in love for our neighbors.

- Porchlight Ministry, coat and food drives, Christmas Giving Tree, and grants on behalf of literacy projects in Cambodia and Anglican Churches in Ramallah
- Medina Days, Temple De Hirsh Sinai Partnership and Bellevue Pride.
- David Porter & our calling to to bear witness to God's love for all people through the ministry of reconciliation



Our children and youth programs grew.



- Our numbers **doubled** from last year.
- We have **15-20 children** regularly attending Sunday School. This fall, we added a second classroom.
- We welcomed **20+ kids** at Vacation Bible Camp last year and added an extended-day option.
- This fall, **13 teens** signed up for confirmation class, a class that has not been offered since June 2021.



Our music program grew.

- We celebrated Doug Cleveland's tenure and warmly welcomed Paul Meier.
- Our Chorister program is one of the largest in the area, with 45 choristers who will join our adult choir on their England tour, including a choir. residency at St. Paul's Cathedral.
- The Music Guild hosted its first Gala concert series that was incredibly well-received by the wider community.




The improvement from 2024 FPM to 2024 Actual Total is due to:

- Revenues higher than expectations by \$161,000

- Net Cost Savings of \$49,000 offset by excess B&G deferred maintenance spending of \$78,000




Our Reserve Fund
